We affirm. On August 2, 2004, Appellant was convicted of aggravated sexual assault. On September 28, 2004, he was sentenced to life in prison. In his sole point, Appellant contends that the trial court abused its discretion by denying his motion for post-conviction DNA testing. Because Appellant filed his motion for DNA testing after the statutory deadline, the trial court did not abuse its discretion by denying his motion. See Tex. Code Crim. Proc.
